Bureau of Investigation & Enforcement (I&E) sought the following relief in its complaint: (1) to impose a civil penalty of two million dollars against Burgly; and (2) to order Burgly to comply with all Commonwealth law and regulations as well as federal regulations as adopted by the Commonwealth. On 4/24/14, Burgly filed preliminary objections. On 5/5/14, I&E filed an Amended Complaint. On 5/23/14, Burgly file Preliminary Objections to the Amended Complaint. On 10/30/18, the Parties filed Joint Petition for Settlement.

- By Order entered 12/6/18, the Commission, inter alia, ordered Columbia Gas to cease the discriminatory billing practice of offering "on bill billing" of non-commodity goods and services offered by two former Columbia affiliates, while denying the same billing option to the Natural Gas Suppliers (NGSs). The Commission's 12/6/18 Order acknowledged that Columbia Gas has discretion to offer such billing service, but it must be offered in a non-discriminatory manner to NGSs that request the same billing service. On 12/20/18 and 12/21/18, CAUSE-PA, and Columbia, respectively, filed Petitions for Reconsideration of the 12/6/18 Order. In order to preserve jurisdiction in these matters, the Commission engaged in a notational voting process on 12/21/18, through which it granted reconsideration pending review of, and consideration on, the merits of the Petitions. The resulting Opinion and Order (short form) granting reconsideration pending review of the merits was entered on 1/4/19.
