1. The scope and description of current eBilling programs

- United Water PA introduced paperless eBilling services for customers in March 2009. Customers can enroll for paperless eBilling via phone, letter or on our website at www.unitedwater.com. If unsure, a customer can opt to take part in a trial of the eBilling service for two billing periods. During this trial the customer will receive both a paper and eBill. At the end of the trial period the customer will automatically revert to eBill only unless they decide to unsubscribe from the service. All disconnection notices for non-payment are sent via paper bill. As an incentive to enroll in eBilling, customers can pay their bill online via their bank account free of charge. Otherwise there is a \$3 processing fee which is paid to Western Union.

2. The current levels of participation in current eBilling programs

- UWPA bills monthly and has a total of 56,235 billable customers. As of April 10, 2009 3,709 customers are receiving paperless eBills; however, 1,523 of these customers have already opted to turn off their paper bill.
- UW Bethel bills quarterly and has a total of 2,348 billable customers. As of April 10, 2009 96 customers are receiving paperless eBills and none have opted out so far.

3. Any changes in tariffs

- We have not and were not planning to make any changes to the tariff. The eBill is exactly the same format as the paper bill and all bill due dates and collection rules etc have not changed.

4. Any changes to eBilling program since inception

- UWPA and UW Bethel began their eBill program in March of 2009. We have not made any changes to the program since it has begun.

5. Information that was or will be contained in bill inserts and other communications.

- In 2008 we promoted eBilling via bill insert. Since the service was introduced we have added a bill message to all paper bills promoting the service and also have included many references to eBilling on our new website. I have included pdf copies of the bill insert that was sent and also an eBilling FAQ which is available on our website also.

6. Any other concerns

- There are many positives relating to eBilling services from a customer service perspective, environmental and cost. We would simply encourage companies to choose eBilling partners carefully and ensure that they have integrated solid security measures and also visible and real-time tracking mechanisms.

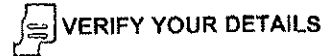
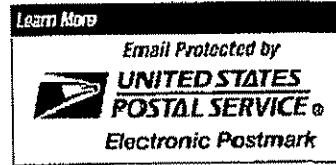

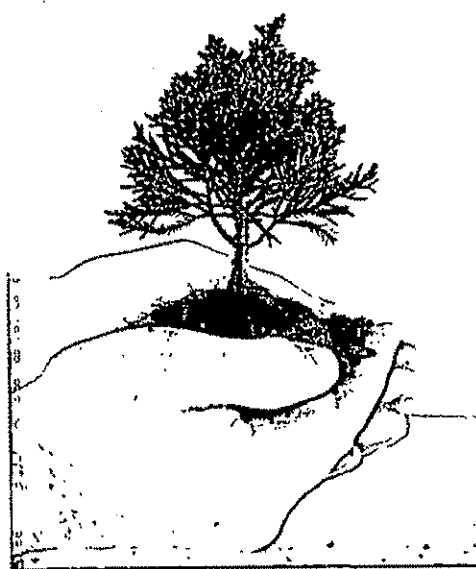
