Approved applications for Pennsylvania Department of Transportation (PennDOT) (**Philadelphia County**), Rolls Royce Rental (**Luzerne County**) and **Pennsylvania American Water Co.**

Adopted opinions and orders granting the petition for reinstatement of certificate for purpose of transfer for Harold Jones

(**Philadelphia County**); granting the petition for reinstatement for Titusville Area Senior Citizen Corp. (**Crawford County**); issuing for comment two settlements with **PPL Electric Utilities Inc.** that include \$471,000 in monetary penalties and contributions to low-income programs, and improvements to customer service procedures and training, ending two informal investigations; granting the joint petition for approval of a revised amendment to an interconnection agreement for **Verizon Pennsylvania Inc.** and **XO Communications Services Inc.**; granting the joint petition for approval of a revised amendment to an interconnection agreement for **Verizon North** and **XO Communications Services Inc.**; dismissing the petition filed by Integrity Transportation Services, LLC related to Reach for the Stars Limo Service (**Philadelphia County**); denying the complainant's exceptions, dismissing the complaint with prejudice and adopting the initial decision in Madalyn M. Ciabattoni vs. Schuylkill Valley Airport Shuttle (**Berks County**); and granting the joint petition of **Embarq** and **Budget Phone** for approval of a master interconnection, collection and resale agreement.

Adopting the joint motion of Chairman Cawley and Commissioner Gardner issuing the Law Bureau Prosecutory Staff (LBPS) vs. **UGI Utilities Inc.** settlement agreement for comment, and requiring the company to pay a civil penalty of \$80,000 and an \$80,000 contribution to UGI's Operation Share Fuel Fund.

Approved the 911 system renewal plans for **Fayette** and **Pike counties.**



Approved a letter of notification of West Penn Power Co. with respect to the partial relocation and reconstruction of portions of three line segments comprising the Kammer-Harrison-Fort Martin 500 kV transmission line in **Greene County**.

Approved a securities certificate for **York Water Co.**

Adopted a revocation order canceling the certificates of public convenience held by **New Rochelle Telephone Corp.**

Granted a petition requesting additional numbering resources in the 717, 484 and 570 numbering plan areas (NPA) for **CTSI LLC** and in the 610 NPA for **Verizon Pennsylvania Inc.**

Adopted the Special Agent's initial decision in Tina Satterwhite vs. **PECO Energy Co.**, establishing a monthly payment schedule.

Adopted the administrative law judge's initial decision dismissing the complaint with prejudice for failure to prosecute in Sylvia Hooke vs. **PECO Energy Co.**

Adopted the motion of Commissioner Pizzigrilli related to Tammy Gephart vs. **PPL Electric Utilities Corp.**, modifying the initial decision of the administrative law judge and dismissing the complaint with prejudice.

Adopted the motion of Chairman Cawley regarding an appointment to the Commission's Consumer Advisory Council.

Adopted the proposed opinion and order granting the Office of Small Business Advocate's petition for reconsideration of the Commission's order approving, with modifications, **PPL Electric Utilities'** proposed rate mitigation plan, pending review of and consideration of the merits.
