Adopted the order waiving the competitive transition charge (CTC) recovery and rate adjustment, and directing PPL Electric Utilities to submit monthly CTC reconciliation statements until the termination of its CTC recovery/refund; approving Supplement No. 99 to Tariff Gas PA PUC No. 9 of National Fuel Gas Distribution; approving the change in rate structure for **North** East Heat & Light Co.; granting in part and denying in part **DPE's** petition for confidential treatment of its 2009 financial report; granting in part and denying in part **Sprint Communications Co. LP's** petition for protective order regarding its 2009 financial report; granting the request of T.W. Phillips Gas & Oil **Co.** for the renewal of the interstate pipeline storage and related transportation service capacity contracts; and granting interim approval of **UGI Utilities Inc.-Electric Division's** request for modifications to its default service security requirements and a waiver of its wholesale supplier bid limitation.

Approved the appointment of Frank D. Plank and Timothy C. Burdis to the advisory board of the **Met-Ed/ Penelec Sustainable Energy Fund**.

Adopted the proposed tentative order noting the recommendation of the Commission's Office of Competitive Market Oversight, making tentative findings relating to the elements to be contained in a uniform eligible customer list and issuing those tentative findings for comment; and issuing for comment the proposed interim guidelines on marketing and sales practices of electric and natural gas suppliers.

Approved the 911 system renewal plan for Juniata and Union counties.

Adopting the ALJ's recommended decision approving and adopting the joint settlement petition and terminating and closing the investigations and complaints regarding proposed changes in revenues for Pennsylvania Utility Co.; approving the statement of distribution system improvement charge revenues and expenses for the 12 months ended Dec. 31, 2009, for Pennsylvania American Water Co.; Newtown Artesian Water Co.; United Water Pennsylvania Inc.; York Water Co.; Columbia Water Co.; and Aqua Pennsylvania Inc.

Approved the letters of notification for PPL Electric Utilities Corp. with respect to the Copperstone-Harrisburg Nos. 1 and 2 138/69-kV transmission line in South Hanover and Lower Paxton townships, Dauphin County with respect to the Middletown Junction-Copperstone 230kV transmission line and the Copperstone-North Lebanon 230kV transmission line in South Hanover Township, Dauphin County.

Adopted a proposed rulemaking with regard to safety regulations to address hazardous materials and liquid fuels, and, in accordance with the Pipeline Safety Grant program payment agreement entered into with the Department of Transportation, to maximize the federal matching funds to the Commission for pipeline safety inspection.

Granted the petition for clarification regarding the Commission's April 19, 2010, order that directed **Columbia Gas of Pennsylvania Inc.** to use proceeds received from a settlement with the Tennessee Gas Pipeline Co. to provide additional funding to Columbia's existing hardship fund until these additional funds are exhausted and provide a portion of the refund settlement proceeds to small commercial customers through Columbia's purchased gas cost rates.

Granted the request of **TCG Pittsburgh Inc**. for a numbering safety valve numbering resource request for additional numbering resources in the 412 numbering plan area.

Adopted the recommendation to implement an all services distributed overlay as the form of area code relief in the 570 area code.

Adopted the motion of Commissioner Powelson denying the petition for reinstatement of Lifestyle Limousine Inc. (Berks County).

Adopted the motion of Chairman Cawley regarding the exceptions of Barker Brothers Inc. (**Allegheny County**) to their objections to their assessment for Calendar Year 2007.

Adopted the motion of Chairman Cawley granting the exceptions of the Pike County Light & Power Co.-Electric and Direct Energy regarding Pike's default service implementation plan.
