Approved applications for Pennsylvania Department of Transportation (PennDOT) (**Lawrence County**); Medallion Transportation Limited (**Montgomery County**); PennDOT (**Westmoreland County**); PennDOT (**Beaver County**); Meadville Area Ambulance Service LLC (**Crawford County**); **Accession Time**; and **Energy Edge Consulting LLC**.

Made public the auditor's report of **Pennsylvania Power Co.**

Approved the orders approving the request for waiver from the provisions of the generation supply charge (GSR) rider that requires it to revise GSR rates, effective Oct. 1, 2010, for **PPL Electric Utilities Corp.**; approving the generation supply service rate adjustments for **Wellsboro Electric Co.** and **Citizens' Electric Co. of Lewisburg**, effective Oct. 1, 2010; approving the reorganization of ownership structure that will eliminate the controlling interest held in **Laurel Pipe Line Co. LP's** indirect general partner; granting **PPL Electric Utilities Corp.'s** petition for a one-time limited waiver to release certain customer information to Pennsylvania State University; and finalizing interim guidelines for advance notification by an **electric generation supplier** of impending changes affecting customer service.

Adopted the proposed opinions and orders granting the petition for reinstatement, conditioned on the filing of renewal insurance with the Commission within 30 days for Best of Times Chauffeured (**Chester and Montgomery counties**); approving the proposed settlement in the Bureau of Transportation and Safety (BTS) vs. Altoona USA & Transfer (**Blair County**); approving the settlement in BTS vs. Classy Cab Co. Inc. (**Butler County**); denying the complainant's exceptions and adopting the Administrative Law Judge's (ALJ's) initial decision in Huiping Xu vs. **Peoples Natural Gas**; denying the petition for reconsideration filed by the Office of Consumer Advocate regarding **PPL Electric Utilities Corp.'s** smart meter technology procurement and installation plan; denying the petition for reconsideration regarding the transfer application of **Kennedy Transfer Inc.**; granting the

petition for expedited approval of early filing of the Alternative Energy Portfolio Standards charge and release of default service procurement results filed by **PECO Energy Co.**; granting the Borough of White Haven's petition for reconsideration pending review of, and consideration, on the merits in White Haven Borough vs. **Reading Blue Mountain & Northern Railroads**, and denying the borough's petition for stay pending disposition of the petition; and granting **AAA Worldwide Transportation Inc.'s** petition for reconsideration pending review of, and consideration on, the merits.

Approved a tariff supplement proposing an industrial pretreatment program for Conewago Industrial Park – Sewer (**Cumberland County**).

Approved an increase in rates for Elverson Water Co. Inc. (**Chester County**).

Instituted an investigation in the rate request of Superior Water Co. Inc.

Adopted two secretarial letters providing the state certification of **rural telephone carriers** to the Federal Communications Commission.

Granted the petitions of UGI Central Penn Gas Inc. (UGI-CPG) for an order authorizing the company to revise its accounting methodology for gas in storage inventory; to intervene, raising a number of issues and arguments in opposition of the **PPL Electric Utilities Corp.** universal service plan and transfer the plan to the Office of Administrative Law Judge .

Adopted the ALJs' initial decision dismissing Johnson's complaint and dismissing with prejudice Cothran's complaint for lack of prosecution in Timothy R. Johnson and Hixcy Cothran vs. **Global Tel*Link Corp.**

Granted a request for additional numbering resources in the **724 area code to Consolidated Communications.**

Adopted the motion of Chairman Cawley related to Charisee Bennett vs. **Peoples Natural Gas.**
