Approved applications for Jitney Home Care Transportation Inc. (**Allegheny County**); Hybrid Planet Chauffeur Service LLC (**Delaware County**); Pennsylvania Department of Transportation (PennDOT) (**Lehigh County**); Honesdale EMS (**Wayne County**); Quality Limousine Service (**Allegheny County**); Robertson Towncar Service (**Delaware County**); **Pennsylvania American Water Co.**; **High Meadows Mobile Home Park**; **Energy Initiatives Inc.**; and **Mosaic Networkx LLC**.

Dismissed the application of Gerardo's Transportation Taxicab Co. (**Franklin, Adams and Fulton counties**).

Approved an application for discontinuance or abandonment of service for Medical Transport Services (MTS) (**Huntingdon County**).

Approved increases in rates for Walls/Delaware Valley Havertown/Westtown Movers LLC (**Philadelphia, Delaware, Chester, Montgomery**

and **Bucks counties**); Central Van & Storage of Charleston Inc. (**Washington County**); Hammer's Moving & Storage Inc. (**Montgomery and Bucks counties**); and Jensen Movers & Storage Inc. (**Montgomery County**).

Adopted the proposed opinions and orders denying the appeal by Trident Inc. (**Philadelphia County**) regarding a complaint instituted against the company alleging failure to maintain evidence of insurance on file with the Commission; remanding the application of Scott R. Rice to begin transporting persons in limousine service between points in **Allegheny County**; granting the petition for reconsideration pending review of and consideration on the merits in the case of John Peluso vs. **Pennsylvania Power Co.**; denying the exceptions, adopting the initial decision and dismissing the complaint with prejudice in the case of York Road Realty Co. vs. **PECO Energy Co.**; granting, in part, and denying, in part, the complainant's exceptions, modifying the initial decision of the administrative law judge (ALJ) and denying the complaint in Gerald S. Lepre Jr. vs. **Equitable Gas Co.**; issuing for comment the proposed settlement of **PPL Electric Utilities Inc.** pertaining to an informal investigation of the termination of a residential account for nonpayment on June 10, 2010; adopting the proposed settlement in the case of BTS vs. **George E. Carroll General Hauling**; denying the complainant's exceptions to the ALJ's initial decision, and adopting the initial decision as the action of the Commission in Shira Meng Master Holding LP vs. **Philadelphia Gas Works**; approving the proposed settlement agreement regarding an increase in rates and regarding the proposed sewage service between **CMV Sewage Co.** and the North Codorus Township Sewer Authority (**York County**); granting the joint petition of **AT&T Communications of Pennsylvania** and **Windstream Pennsylvania LLC** seeking approval of an amendment



to an interconnection agreement; and granting the reconsideration filed by **AT&T Communications of Pennsylvania, TCG Pittsburgh** and **TCG New Jersey**; and the **PTA** and **CenturyLink's Joint Petition** for Limited Reconsideration and Stay in the **Rural Local Exchange Carrier** Access Charge Investigation, pending review and consideration based on the merits of the petitions.

Adopted the proposed orders approving the affiliated interest agreement and registering the securities certificate for **National Fuel Gas Distribution**; adopting revisions to the Commission's organizational structure, consistent with **Act 129 of 2008**; granting the petition of **Windstream Pennsylvania LLC** for a bona fide retail request deployment extension of six months for specific exchanges; granting **Verizon Pennsylvania Inc.'s** request for additional numbering resources in the 570 area code; and granting the petition for reconsideration, pending later disposition on the merits, of **Citizen Power** and **Pennsylvania Steel & Cement Manufacturers Coalition** asking that the Commission conduct an investigation into stranded costs recovered by **Pennsylvania electric distribution utility companies** and order refunds, if necessary.

Approved the 911 system renewal plans for Northumberland County.

Adopted the AL's initial decision dismissing the complaint in the case of Theodore Mosier vs. **UGI Utilities Inc.**; denying the complaint in the case of Alia Stayton vs. **PECO Energy Co.**; dismissing the complaint for lack of jurisdiction in the case of Dominic and Bunito Longo vs. **Verizon Pennsylvania Inc.**; dismissing the complaint in the case of Catherine Alpohoritis vs. **Philadelphia Gas Works**; and approving the settlement in the joint application for approval to transfer the interests and shares in DQE Holdings LLC, currently owned by DUET Investment Holdings Limited, to Epsom Investment Pte Limited, a subsidiary of GIC Infra Holdings Pte Limited, and the resulting change in control of **Duquesne Light Co.**

Adopted the AL's recommended decision approving the joint settlement regarding changes in the **Peoples Natural Gas Co.** purchased gas cost rates.

Appointed Paul Diskin the Director of the Bureau of Technical Utility Services and Johnnie E. Simms the Director of the Bureau of Investigation and Enforcement.

Adopted the joint motion of Chairman Powelson and Commissioner Cawley modifying the joint petition for settlement regarding the base rate filing, and energy efficiency and conservation plan of **UGI Central Penn Gas Inc.**
