Adopted the proposed opinions and orders approving the proposed opinions and orders granting the Exceptions filed by Consolidated Communications Enterprise Services, Inc.; dismissing the Exceptions by Omnipoint Communications, Inc. d/b/a T-Mobile, et al., as moot; denying T-Mobile's Preliminary Objections; reversing the administrative law judge's (ALJ's) recommended decision and remanding the matter for hearing and recommended decision on the formal complaint of Consolidated Communications Enterprises Services, Inc. vs. **T-Mobile** et al; approving the revised energy efficiency and conservation plan, subject to certain additional modifications to bring the revised plan into compliance with the October 2011 order of UGI Utilities Inc. - Electric Division; granting, in part,

and denying, in part, Pennsylvania Communities Organization for Change's (PCOC) petition and modifying the ALJ's recommended decision with regards to **Columbia Gas of Pennsylvania Inc.'s** Customer Assistance Plus Program; granting, in part, and denying, in part, the exceptions of Melissa Randall and adopting the ALJ's initial decision as modified in the case of Melissa Randall vs. **PECO Energy Co.**; regarding **YEP & Y.E.P. Energy** and granting the petition of rescission or amendment in response to the Dec. 16, 2011, Secretarial Letter regarding the name change application of **Linde Corp**.

## Registered the securities certificate of Columbia Water Co.

Instituted an investigation in the proposed rate increase request of Audubon Water Co.

Approved joint petitions for settlement for Corner Water Supply & Service Corp. and United Water Bethel Inc. rate increases.

Approved a motion by Chairman Robert F. Powelson to deny the exceptions, reject the settlement agreement and remand the matter back to the Administrative Law Judge in the case of PUC v. Night Moves.

Adopted final rulemaking on call recording for telephone companies.

**Approved a combined motion by Commissioner James H. Cawley** to reopen the investigation regarding intrastate access charges paid by **long-distance companies** to incumbent **rural telephone companies** and to examine the cross effects of the November 18, 2011 FCC Order on the PA PUC July 18, 2011 Order. The motion also initiates a second proceeding relating to the prospective implementation of the November 18, 2011 FCC Order with a collaborative technical conference to take place no later than April 20, 2012.
