By Order entered February 17, 2010 in the above-captioned proceeding, the Public Utility Commission (Commission ) invited interested Parties to comment on revised Figures 4, 5 and 47 and revised Table 6A that were submitted to the Commission by Duquesne Light Company as a supplement to its original Compliance Filing, made December 24, 2009.
