
Dear Mr. McNulty,

On January 22, 2009, the Pennsylvania Public Utility Commission ("Commission") ordered that a license be issued authorizing Gexa Energy Pennsylvania, LLC ("Gexa") to provide electric generation supplier services to the public throughout Pennsylvania. The Order noted that Gexa did not intend to provide electric generation supplier services to residential customers and required Gexa to immediately notify the Commission if Gexa chooses to do so in the future.

While Gexa does not intend at this time to generally enter the residential market, it may, in certain instances, provide electric generation supplier services to commercial customers as to which a component of such service may include residential accounts. As such, Gexa is hereby providing notice thereof to the Commission as required by the Commission's Order, and Gexa acknowledges that it will be required to comply with, and be governed by, applicable Chapter 56 residential service regulations in connection therewith.

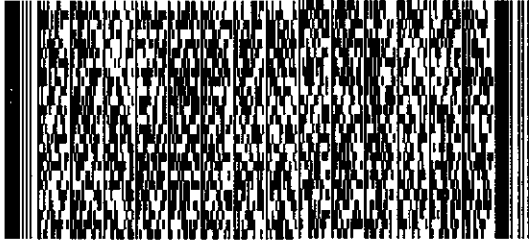

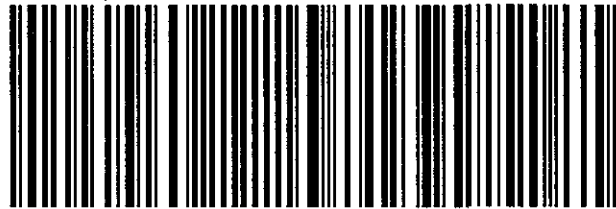
