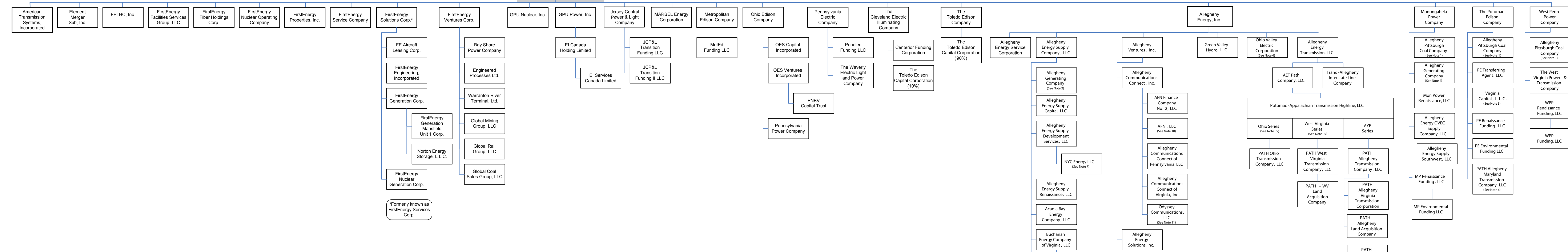

¹ FirstEnergy Corp. owns a 14.34% interest in First Communications, Inc. as of October 29, 2008. FirstEnergy Corp. and First Communications, LLC owns a 23.529% and 42.396% interest respectively in FS Holdco, LLC as of December 1, 2009.

² FirstEnergy Ventures Corp. owns a 50% interest in Engineered Processes Ltd.

³ FirstEnergy Ventures Corp. owns a 50% membership interest in each of Global Mining Group, LLC, Global Rail Group, LLC and Global Coal Sales Group, LLC. Global Mining Group, LLC is the sole member of Signal Peak Energy, LLC, which owns land and other assets used in the operation of the Bull Mountain Coal Mine. Global Rail Group, LLC, owns land and other assets for a railroad spur track and power line servicing the Bull Mountain Coal Mine. Global Coal Sales Group, LLC is the exclusive marketer of coal produced at the Bull Mountain Coal Mine.

⁴ El Canada Holding Limited and El Services Canada Limited have had their Nova Scotia registrations revoked. Neither has had their corporate charters revoked and are currently in dormancy.

⁵ Ohio Edison Company owns a 7.5% interest in Ohio Valley Electric Corporation ("OVEC"), a public utility organized in 1952. The Toledo Edison Company ("Toledo Edison") owns a 4.0% interest in OVEC, representing FirstEnergy's combined interest of 11.5%. OVEC owns 100% of the stock in Indiana-Kentucky Electric Corporation ("IKEC"). These organizations were created by 15 independent investor-owned utilities to provide electricity to a Department of Energy uranium enrichment complex in the Ohio Valley.

⁶ FirstEnergy Corp. owns a 17.83% interest in PowerSpan Corp. as of November 23, 2009.

⁷ The Toledo Edison Company owns a 90% interest in The Toledo Edison Capital Corporation, with The Cleveland Electric Illuminating Company owning the remaining 10% interest.

⁸ The Toledo Edison Capital Corporation owns a 6.55106% interest in Shippingport Capital Trust as of October 13, 2008.
