NOTICE OF WITHDRAWAL OF PROTEST

The Retail Energy Supply Association (“RESA”) hereby files this Notice of Withdrawal of Protest in the above-referenced proceeding. In support of this Notice, RESA states as follows:

1. On September 17, 2010, Interstate Gas Supply, Inc., d/b/a IGS Energy (“IGS”) filed by letter an update and amendment to the Initial Application for Natural Gas Supply Services to the Public filed on November 11, 1999, pursuant to 52 Pa. Code § 62.105. The notice advised the Commission that IGS will be using a fictitious name or doing business as (“d/b/a”): IGS Energy and Columbia Retail Energy.
2. RESA filed a Protest and Petition to Intervene on October 14, 2010.
3. On November 10, 2010, the Office of Consumer Advocate (“OCA”) filed with the Commission a Notice of Intervention in this proceeding.
4. On November 15, 2010, IGS submitted a supplemental filing with the Commission that committed it to the use of certain disclaimers in connection with IGS' utilization of the fictitious name, Columbia Retail Energy.
5. RESA’s objections to the IGS’ update and amendment to its Initial Application have been satisfied as a result of IGS' supplemental filing and other considerations arising from a settlement of the differences between IGS and RESA. As a result, RESA hereby requests leave to withdraw its Protest in this matter.

6. If upon receipt of RESA's Notice of Withdrawal of Protest, the above-captioned proceeding is not deemed closed, RESA reserves the right to continue participating as an active party in this matter.

WHEREFORE, for all the reasons set forth above, RESA respectfully requests to withdraw its protest in this matter.
