# Out of Pocket Expenses

60 -(C)

All tolls, parking fees, and other such out-of-pocket expenses incurred as a result of a customer's request for a deviation in the carrier's regular route while providing service will be the responsibility of the customer and will be added on to the carrier's charge.

# 70 - Cleaning Fees & Damage Charges

(C)

The customer shall assume responsibility for any and all damages incurred and will be invoiced accordingly. A cleaning fee of up to \$100.00 will be assessed to any invoice where the vehicle has been returned in need of cleaning which the carrier determines to be excessive or unusual.

# 80 - Promotional Fares

(C)

Upon presentation of advertising coupon or special promotional offer, carrier will offer rates at a specified discount from the published tariff rates on dates authorized by the coupon or other special promotional offer. Advertised coupon or promotional offer will be filed with the Public Utility Commission prior to publication/broadcast. Coupons will be published, and promotional offers will be broadcast in one or all of the following: Local Newspapers, Fliers and other printed media, and all forms of radio and television advertising media including the internet.

# Vehicle Descriptions

All vehicles referred to as limousines shall have a minimum of the following; leather seating, darkened windows, a privacy partition, dual heating and air conditioning systems, color TV, Video cassette or DVD player, and a deluxe stereo system.

All Sedans, Vans or Sport Utility Vehicles shall be designated as such by the vehicle manufacturer and shall have a minimum of the following; leather or custom cloth interiors, deluxe stereo system, heating and air conditioning.

All seating capacities are designated by the vehicle manufacturer and shall not be exceeded.

# **Definitions**

# Frequent User

A Frequent User shall be defined as any customer who utilizes  $\mathcal{E}_{ypressubes}$ Limousine of Lancaster services for seven (7) or more airport transfers in the previous twelve (12) month period.

- Acceptance of Reservations
- 10 -(C)

Reservations must be made the calendar day or a minimum of eight hours prior the service being rendered, whichever is longer. Frequent users must make reservations no less than four hours in advance.

## 20 - Deposits (C)

As a condition of accepting a reservation to charter a vehicle, the carrier requires a deposit of not more than 20% of the quoted charter price. Forfeiture of deposits to be within the following limitations:

- 1. Forfeiture of not more than 50% of the deposit if the charter is cancelled by the customer more than 15 but less than 30 days prior to the date the transportation was to depart, and
- 2. Forfeitures of not more than the total amount of the deposit if the cancellation occurs within 15 days prior to the date the transport was to depart.

# 30 - Final Payment

(C)

The carrier will not authorize credit unless an approved credit account is in place for the chartering party. All anticipated charges must be paid in full seven (7) days prior to the date the transport is to depart or at the time of reservation, whichever is less. Any additional charges must be paid by cash, check or credit card by the chartering party when the trip is completed unless an approved credit account is already in place.

## 40 - Holiday Assessment

(C)

Reservations made for service provided less than fourteen (14) days prior to the following holidays will be assessed at 125% of the published charge: New Year's Eve, New Year's Day, Valentine's Day, Easter, Memorial Day, Fourth of July, Labor Day, Thanksgiving Day, Christmas Eve, and Christmas Day. Reservations for service provided made fourteen (14) days or more before these holidays shall be invoiced at the published charge.

- 50 Driver Gratuity
- (C)

A fifteen percent (15%) Driver Gratuity will be assessed in addition to all other published rates. All gratuities will be calculated based on regular rates and added to invoices prior to any discounts being applied.
