Dear Secretary Chiavetta:

This letter is intended to inform the Pennsylvania Public Utility Commission (Commission) of an internal corporate reorganization within the Constellation Energy Group, Inc. (CEG) family that will result in an anticipated temporary change in minority ownership of Constellation NewEnergy, Inc. (CNE), a licensed Retail Electric Generation Supplier. As detailed in Attachment A to this Letter, the reorganization will not impact any element upon which CNE relies in order to satisfy the requirements of the Commission's licensing rules.

Because the nature of the reorganization described in Attachment A to this letter is maintained by CEG in a confidential manner, CEG asks that the Commission and its Staff treat the information provided therein as **CONFIDENTIAL**, as it represents commercially and competitively sensitive information. We have provided both public and confidential versions for your files.

We will, of course, keep you apprised of the ongoing internal corporate reorganization if it impacts any licensed entity under the CEG family as contemplated in 52 Pa. Code §54.34 and 52 Pa. Code §54.33. In the interim, please feel free to call or email with any questions.
