By Order entered May 7, 2004, the Pennsylvania Public Utility Commission ("Commission") approved the Petition to Transfer Natural Gas Supplier License from Agway Energy Services-PA to Agway Energy Services, LLC ("Agway"), at Docket No. A-125125, to provide Natural Gas Supply service to the public in the service territories Columbia Gas of Pennsylvania Inc. and The Peoples Natural Gas Company.
