
Dear Sir:

On March 5<sup>th</sup> 2012 at the public hearing held in the East Goshen Township Building, during the Aqua V Pennsylvania Public Utility Hearing. Mr. Alford Conan in his sworn testimony alleged that Aqua contractors were required by townships to repair roads beyond the area damaged during his repair work and that these costs were driving his costs/price up. He stated that townships were having budget problems and shifting the burden of street repair to Aqua.

Request you ask the Pennsylvania Attorney General's Office to investigate this allegation and if true have this practice stopped.

I understand that all Pa residents are taxpayers, but not all PA residents are Aqua customers. Additionally Aqua is using DSIC funding to fund much of this work. DSIC is an important part of this rate case. An early resolution of this allegation is needed. I have not received the hearing transcript at this time. The name of the contractor was taken from my hand written notes. Please correct the spelling of contractors name if incorrect.
