PA PUBLIC UTILITY COMMISSION SECRETARY'S BUREAU

AN ORDINANCE OF THE COUNTY COMMISSIONERS OF THE COUNTY OF BERKS, PENNSYLVANIA, LEVYING AN IMPACT FEE ON UNCONVENTIONAL GAS WELLS ESTABLISHED IN BERKS COUNTY, PENNSYLVANIA

WHEREAS, House Bill 1950, Act 13 of 2012 effective February 14, 2012 of the Pennsylvania General Assembly (the "Act") empowers counties to levy an impact fee on unconventional gas wells; and

WHEREAS, the County of Berks (the County") desires to enact an ordinance to permit the levy of an impact fee on unconventional gas wells located in the County.

NOW, THEREFORE, IT IS HEREBY ENACTED AND ORDAINED by the Board of Commissioners of the County of Berks, Pennsylvania:

- 1. The County hereby imposes an unconventional gas well fee on each unconventional gas well spud in the County.
- 2. This ordinance adopts all provisions of the Act by reference including specifically all definitions outlined in subsection 2301 of the Act.
- 3. This ordinance shall become effective ten (10) days after its enactment by the Board of Commissioners of Berks County.
