Madam Secretary:

UGI Penn Natural Gas, Inc. ("PNG") herein respectfully requests a second thirty (30) day extension of time to file Exceptions and Reply Exceptions to the Initial Decision of Administrative Law Judge David A. Salapa issued by Secretarial Letter dated March 20, 2012. Consistent with the policy of the Pennsylvania Public Utility Commission, 52 Pa. Code § 69.401, the two parties affected by the Initial Decision, Leatherstocking Gas Company, LLC ("Leatherstocking") and PNG, have actively been engaged in settlement discussions. If a settlement is achieved, it would fully resolve these parties' respective issues in the above-referenced matter, as well as in the competing Application filed by PNG at Docket No. A-2012-2284831.

On March 28, 2012, Leatherstocking and PNG jointly requested an extension of the due date for Exceptions and Reply Exceptions, which was granted on March 29, 2012. Exceptions to the Initial Decision in the above-referenced matter are presently due on or before April 30, 2012, and Reply Exceptions due ten (10) days thereafter.




