I will make this letter to the point as you are well aware of my feelings on this major issue that effects all residents of Historic Districts in the commonwealth.



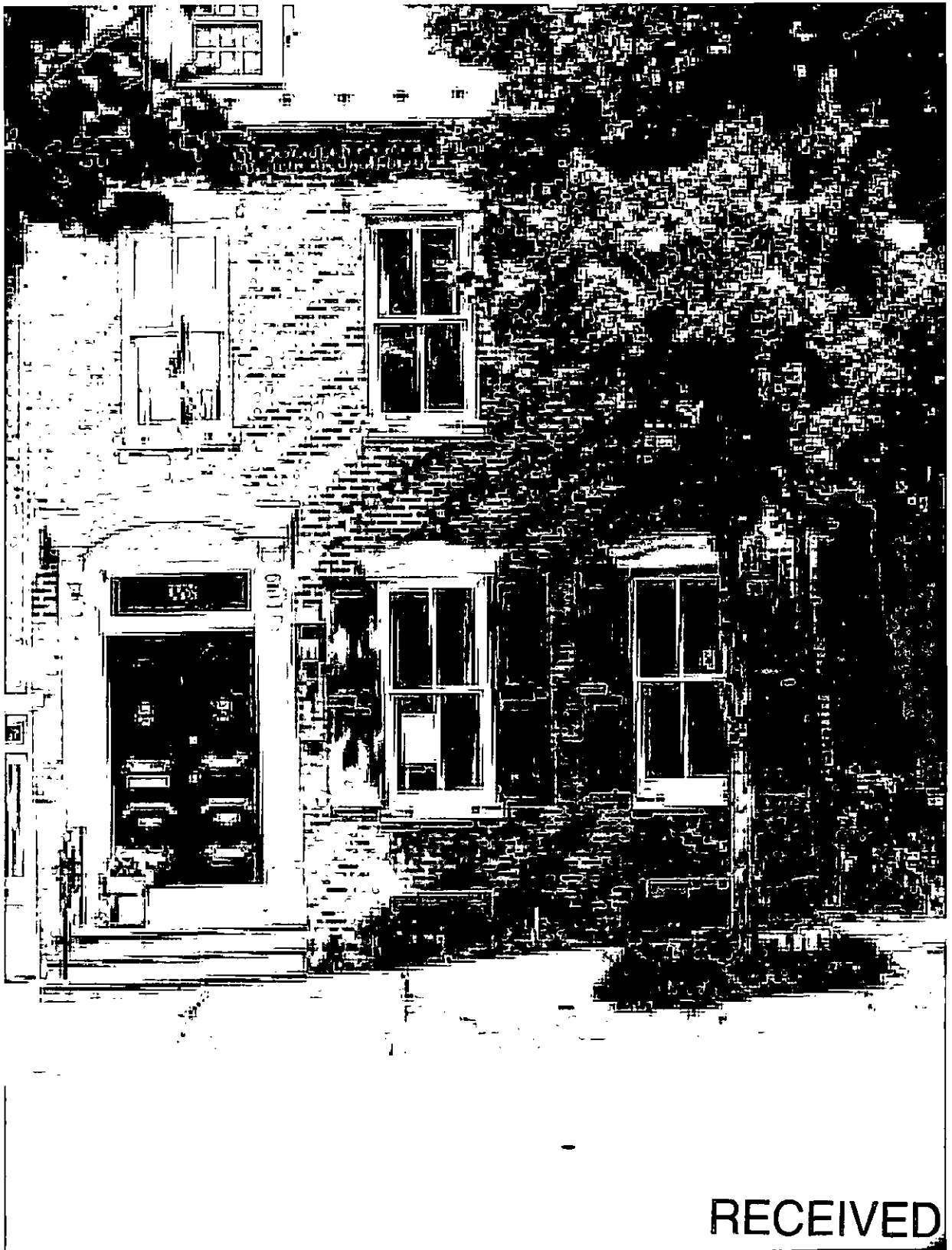

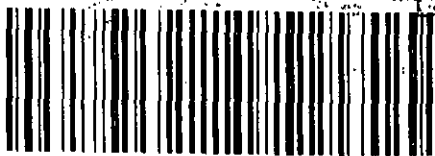
