**PREHEARING MEMORANDUM  
OF THE OFFICE OF SMALL BUSINESS ADVOCATE**

**I. INTRODUCTION**

The Office of Small Business Advocate (“OSBA”) is authorized to represent the interests of small business consumers of utility services before the Pennsylvania Public Utility Commission (“Commission”) pursuant to the provisions of the Small Business Advocate Act, Act 181 of 1988, 73 P.S. §§ 399.41 – 399.50 (“the Act”). In order to discharge this statutory duty, the Small Business Advocate deems it necessary to participate as a party to this proceeding. **II. FILING BACKGROUND**

Act 129 of 2008 (“Act 129”) was into law on October 15, 2008. Act 129 requires that each electric distribution company (“EDC”) with at least 100,000 customers must develop and

file an Energy Efficiency & Conservation Plan (“EE&C Plan”) with the Commission for approval. Metropolitan Edison Company (“Met-Ed”) developed, filed, and received approval of its initial EE&C Plan.

On August 3, 2012, the Commission entered the *Phase II Implementation Order* at Docket Nos. M-2008-2069887 and M-2012-2289411, tentatively adopting EDC-specific targets for reduced energy consumption in Phase II of the EE&C Program, to run from June 1, 2013 through May 31, 2016. Met-Ed filed its Phase II EE&C Plan with the Commission on November 13, 2012.

### **III. IDENTIFICATION OF WITNESSES AND TENTATIVE ISSUES**

The OSBA does not have the resources to undertake a detailed evaluation of every Pennsylvania EDC’s EE&C Plan. Nevertheless, within its constraints, the OSBA intends to review Met-Ed’s proposed EE&C plan to evaluate whether:

- 1) Small business customers are assigned a reasonable share of the overall EE&C programs, neither disproportionately large or small;
- 2) Costs for the various EE&C programs are reasonably and equitably assigned and allocated among the various rate classes;
- 3) Programs focusing on small business customers have TRC Test benefit-cost ratios that are reasonably similar to those for other customers;
- 4) The proposed cost recovery and reconciliation mechanisms reasonably assign EE&C program costs *within* the rate classes containing small business customers and are consistent with sound utility ratemaking policy;
- 5) These or any other aspects of the Company’s filing are unreasonably discriminatory to small business customers.

The OSBA is still evaluating the filing as well as the need to file direct testimony in this matter. However, to the extent that the OSBA may need to respond to issues raised by any of the other parties to this proceeding, the OSBA will submit the testimony of:

Even if it does not file testimony, the OSBA reserves the right to brief legal questions.


**IV. SERVICE OF DOCUMENTS**


