In order to assimilate the information learned at the sessions into its Initial Tariff and Affiliated Interest Agreement, and in view of the upcoming holidays, Leatherstocking requests additional time in which to file its initial Tariff and its Affiliated Interest Agreement which presently are due December 31, 2012. Specifically, Leatherstocking asks that the filing requirement be extended to Thursday, January 31, 2013. Extending the filing will give Leatherstocking and the various Commission bureaus time to continue to work toward the
