Dear Judge Bell,

I received a copy of your interim Order dated Feb. 7, 2013 and I must say that your Order is perplexing. Be advised that Complainant will NOT be ready for the March 22, 2013 hearing as discovery is ongoing and incomplete largely due to both respondent's actions and inactions. Furthermore your rulings on specific interrogatory responses are not supported by respondent's "responses" which cannot be enumerated completely herein due to the voluminous nature of such an undertaking however a sampling of the numerous examples is your ruling on Interrogatory #6a. As a matter of fact the respondent has simply not provided the requested information as requested and even a cursory review of what respondent actually did provide instead of simply restating respondent's so-called "response" would clearly show that this Complainant's Interrogatory was not responded to adequately and to any degree of acceptability. Furthermore to support Complainant's herein example the respondent previously stated by way of their answer to Complainant's complaint that it "did not keep records" back to 2008 - which then begs the questions did respondent file a false averment in it's answer or did they NOT provide the requested information. This is but one example of respondent's inadequate "responses" to which this commission is choosing to ignore. Please be advised that the Commission will leave the Complainant with no other option than to file an appeal to Commonwealth Court should the March 22, 2013 hearing take place without Complainant's discovery being completed or withdraw Complainant's complaint without prejudice and file a complaint with the Civil Courts while preserving all rights to re-file and/or continue Complainant's case with the commission at a future date.
