

JOHN C. JUSTICE and LINDA S. JUSTICE, husband and wife, (hereinafter "Justices") hereby submit this Protest to this Application and in support thereof make the following representations:

1. Justices are the owners of certain real property located in Salem Township, Wayne County, Pennsylvania, comprising 21.41 acres and identified by Wayne County Tax Parcel No. 22-322-18.02 (hereinafter the "Property").
2. The proposed PPL Project involves the installation of transmission lines and a tower on the Property, which is also identified by PPL as A-2012-2341107.
3. That PPL has advised Justices that they will need to acquire approximately 5.3 acres of ROW that will cut through the heart of the Property.

4. That the proposed route of the transmission line across the Property is inappropriate, as there is an existing transmission line ROW nearby that would eliminate crossing the Property and the need for additional towers, by eliminating a 90-degree turn that is proposed on the Property.


5. That Justices believe that the proposed Project will not serve the needs of the public in Salem Township, Wayne County, Pennsylvania.

6. Justices have standing to protest this Application because their Property will be directly impacted if it is approved.

WHEREFORE, John C. Justice and Linda S. Justice hereby request the Commission either to deny the Application or to require the Applicant to re-locate its transmission lines so that they do not cross the Property.
