- In my resume, I mentioned Pennsylvania's Alternative Energy Development Program (AEDP). The Commonwealth of Pennsylvania's Department of Community and Economic Development awarded us ten million dollars specific to energy-related investments.
- We at Ben Franklin Technology Partners have had our AEDP in place for over 3-1/2 years now. Through this program, we invest in early-stage companies with innovative energy-related technologies. <u>Methodology</u>

Following a multi-faceted recruitment effort by SEF, resumes of applicants for Board membership were forwarded to the consultant. Consultant contacted applicants to schedule---at their convenience--a telephone interview approximately 30 minutes in length. Each applicant was evaluated according to SEF Priorities, based on the interview, their resume and cover letter (if applicable). A supplemental outreach was conducted near the close of the application period. This included contacting the region's three major Chambers of Commerce, Ben Franklin Technology Partners, and the Manufacturers Resource Center of Northeastern PA to stimulate additional interest.

The project was completed in three phases as follows:

Phase 1: INTRODUCTORY

- Contact applicants and schedule interviews
- Greetings, introductions and overview of SEF
- Determine continued interest of candidate
- Confirm residency/workplace requirement (PPL service area)
- Ascertain how candidate learned of opening (most frequently mentioned was the "Business Journal", second was "I received an email")

Phase 2: QUESTIONS, RESPONSES AND WRAP-UP

- Pose twelve broad questions paralleling the thirteen (13) categories in SEF's three (3) Priority Areas.
- Intersperse targeted and followup questions with broad ones to clarify and elaborate
- Give candidate opportunity to provide additional information or ask questions
- Wrap-up interview with verbal commitment that applicant will be provided closure in one of the following forms:

a. Applicant called for interview.

b. Applicant not called for interview, thanked for interest, and notified to apply for future openings if desired.

c. Applicant not to be interviewed at this time, but may be considered at a later date. Application remains active for one year.

Prior to the next item for discussion, Mr. Mickens and Mr. Griffiths recused themselves and dropped off the call at this point as each had a conflict of interest related to PPL Electric's Phase II EE&C Plan.

Ms. Hopkins provided updated information on PPL Electric's Phase II EE&C Plan. The PUC requested that each electric distribution company provide a plan for EE&C measures for Phase II of Act 129. SEF has read PPL's plan, asked questions, provided testimony and filed briefs. An Administrative Judge will not be making a decision on this as it will go in front of the full Commission.

A motion (Zavatone, Roman)

RESOLVED to accept SEF staff's recommendation to participate in the PPL Electric's Phase II EE&C Plan.


