I received notice from the PUC that my application for exemption to the 8 year vehicle limitation, pursuant to 52 Pa. Code § 29.333(e) was rejected for various reasons. The rejection letter was dated February 28, 2013, yet postmarked on Saturday, March 3, 2013. I received it on Tuesday, March 5, 2013. Therefore, I am responding as quickly as possible after gathering the necessary information to request an appeal. Given I did not receive the letter until 6 days after it was written, I am requesting that an extension be granted for my right to appeal within 20 days of the date on the PUC's letter. I am appealing the decision, based upon my right pursuant to 52 Pa. Code § 5.44(a) for various reasons beyond my control.

First, I was deployed to the Middle East from December 2011 to August 2012 as the U.S. Army Medical Logistics Staff Officer (Major) overseeing the drawdown of medical equipment out of Iraq and Afghanistan. Prior to leaving, I contacted the PUC for guidance about my business during deployment and received verbal instruction from Officer Don Adomaitis to suspend my insurance so that my PUC authority would be temporarily revoked (exhibit #1). I was told when I return. I could resume my insurance and my PUC license would be restored (this worked). However, when the PUC contacted me two weeks ago about my request for a vehicle age waiver, Mr. Rodney D. Bender could find no record of my suspension or reinstatement of service even though I have several letters from the PUC to that effect (exhibit #1 and exhibit #2). Officer Adomaitis, sent me a letter dated April 3, 2012 which stated I could complete the forms "upon your return and prior to beginning service" (exhibit #3). I returned home on September 3, 2012, took leave, and was released from active duty shortly thereafter. Thus, I was not available to complete the necessary forms during the PUC's July-September timeframe to request an aged vehicle exemption.

Tragically, at the same time, my two year old daughter was diagnosed with Leukemia. Her health and welfare took precedence over all other matters. Therefore, I did not resume limousine operations until January 2013 once her condition had stabilized. I did, however, market the business and accept reservations for 2013. I never have wedding bookings in the winter months, so therefore, on February 28th, 2013, I submitted my request for an age vehicle exemption when I was ready to resume service for the spring of 2013 (as Officer Adomaitis instructed). After speaking with Mr. Rodney Bender, Transportation Manger, who was exceedingly helpful and very professional I might add, I learned that my application was incomplete and would be rejected because it was not submitted between July and September of 2012 (while I was deployed).

I receive and pay medical bills costing hundreds, sometimes thousands of dollars every month that are not covered by my insurance policy. It would cause not only undue hardship to me and the business, but paying back these deposits would cause me to not be able to provide the medical care my daughter needs to fight her Leukemia. Additionally, I might be forced to file for bankruptcy in order to dissolve the business.

For the reasons mentioned above – military deployment and service to the country during the July – September filing period, my daughter's medical situation, and the business/financial hardship caused by not granting an exemption – I implore the Commission to grant an age vehicle exemption for my car for 2013. I will start the process NOW for 2014 exemption.

Enclosed is a revised request for a waiver, proof of vehicle ownership, photographs on a CD, financial information of the business, maintenance records, reasons why the vehicle is worthy of consideration, and the name, address, and phone number of a certified inspection station. The vehicle was registered in 2005 and inspected numerous times by the PUC. In 2007 after one of the inspections, Officer William Lark, badge #50, contact me about the license plates and said they should be limousine plates, but he talked to his supervisor and said they would not make me change them. Apparently, that decision was never recorded at the PUC. However, as a good faith gesture, I have re-registered the vehicle as a limousine at a cost \$95.


