Re: <u>Standards for Electronic Data Transfer and Exchange Between Electric Distribution Companies And Electric Generation Suppliers at Docket No. M-00960890F0015</u>

In accordance with the Commission's Final Order entered May 10, 2012 at Docket No. M-00960890F0015, UGI Utilities, Inc. – Electric Division is providing formal notice that Change Control #085 and Change Control #087 have been implemented as of April 5, 2013. Change Control #085 provides a net metering indicator for responses to historic usage requests, and for enrollment, change, and reinstatement transaction sets. Change Control #087 adds the future PLC and NSPL values for each customer, when known, to the historic usage transaction sets along with current and future effective date ranges.

Both Change Controls were included in the scope of our EDI Test Plan while testing with a new trading partner in March 2013. Based on the successful results of that testing, the Change Controls were placed into production on April 5, 2013 and all current Electric Generation Suppliers serving customers in the UGI service territory were notified.


