3. Give a general description of the nature and character of the services rendered by the applicant.

The service proposed for discontinuance is a prepaid local exchange residential service offering.

4. Provide a statement of change in service proposed by the company for which Commission approval is sought.

Commission approval is requested for the Company's proposal to discontinue providing (and offering) the Company's prepaid local exchange service offering in Pennsylvania. dPi Teleconnect is evaluating the intrastate and interstate markets to identify viable market offerings going forward and consequently, dPi Teleconnect does not wish to surrender its certificate at this time.

5. Provide a summary of the revenue derived from the operation of the service sought to be discontinued, together with a statement of the expenses accruing from the maintenance of that service. This information may be furnished in detail and attached to the application.

dPi Teleconnect derives approximately \$175/month from current Pennsylvania customers for this service. Due to low subscription numbers, expense generated to provide this service – underlying carrier costs and allocated overhead to maintain Company operations – equals or exceeds the associated revenues.

- 6. Approval of the application is necessary or proper for the following reasons: Commission approval of this plan is necessary and proper and will serve the public interest. In response to changing market conditions, dPi Teleconnect has determined that it is no longer feasible to continue to offer this service package. Carrier flexibility to reformulate service offerings is an integral component of a successfully competitive telecommunications market. At the same time, the services offered by dPi Teleconnect are available from other providers in the Pennsylvania market. Thus dPi Teleconnect's customers will be able to transition smoothly to new providers. Further, dPi Teleconnect's customers have been given 60+ days' advance notice of the need to select a new provider, ensuring that they have sufficient time to do so in an effective manner. Company representatives will be available throughout the transition period to assist customers with this process.
- Provide a detailed explanation of why the company wishes to abandon its certificate.
 dPi Teleconnect does not wish to abandon its certificate at this time. The Company seeks approval solely for discontinuance of a specific service offering.
- 8. Provide the number of customers served and date last served.

 The Company currently provides this service offering to 3 customers.
- 9. What happened to these customers? Who is serving them now? These customers are being served by dPi Teleconnect at this time.
- 10. Are there any NXX Codes assigned to your company? If yes, how many? dPi Teleconnect operates as a reseller and obtains numbers from its underlying carrier. No NXX codes are assigned directly to the Company
