OPERATING AUTHORITY

To transport, as a common carrier, persons in Group & Party service, in vehicles seating eleven (11) to fifteen (15) passengers, including the driver, from points in Allegheny County to points in Allegheny County and return.

RULES AND REGULATIONS

- ITEM 1 - Any damage to the vehicle caused by the charter party will be charged to the charter party.
- ITEM 2 - Time will be calculated from when the vehicle leaves the carrier's garage to when it returns to the carrier's garage.
- ITEM 3 - All parking fees, toll charges, permit fees or similar expenses incurred will be collected from the charter party. All costs incurred by the carrier at the request of the charter party for entrance fees to park, picnic grounds or recreational areas, or other similar incidental costs, will be collected from the charter party.
- ITEM 4 - In addition to the other charges, charter party will be responsible for the lodging of the driver where the charter movement involves an overnight layover.

- ITEM 5 - Van: This vehicle has twin heating and air-conditioning systems, darkened windows, and a deluxe stereo system.
- ITEM 6 - V.I.P. Coach 0-3 years old: This vehicle has a cellular telephone, special interior lighting, a deluxe stereo system, a CD player, two color televisions, a VCR, a DVD, darkened windows, couch seating and dual air-conditioning systems.
- ITEM 7 - V.I.P. Coach (Old Body Style) 4-8 years old: This vehicle has a cellular telephone, special interior lighting, a deluxe stereo system, a CD player, two color televisions, a VCR, darkened windows, couch seating and dual air-conditioning systems.
