Application of Aqua Pennsylvania, Inc. - Bristol Township Water System

Dear Secretary Chiavetta:

We are counsel to Aqua Pennsylvania, Inc. (Company) in the above matter which concerns its Application to acquire the water system of Bristol Township (Township) in Bucks County and to expand its water service territory to include an additional portion of the Township. The Public Utility Commission (Commission) approved the Application in an Order entered March 29, 2012.

As we explained in our prior letter of June 14, 2013, as the Company was preparing for closing, it became apparent that the service territory boundary between the Township and the neighboring Lower Bucks County Joint Municipal Authority (LBCJMA) is not where the Township originally believed it to be and is, instead, inside the Eastern boundary of the proposed additional service territory presented on the map included with the Company's Application.

To accurately depict the additional portion of the Township that the Company will be serving, we enclosed with our June 14 letter for inclusion at this docket, a revised service territory map. The revised map presents the boundary between the Township and the LBCJMA as it is now known and reduces the geographical size of the additional service territory that the Company will be serving in the Township.

Following the submission of the revised map, the Bureau of Technical Utility Services asked that we prepare and submit a revised description of the additional Bristol Township service territory to accompany the revised map. The revised description is enclosed with this letter. Please include it, along with the revised map, at this docket. The revised description replaces the original description submitted by the Company as Appendix B to its Application.

Newportville Ferguson Description of Revised Requested Territory July 26, 2013

All that certain tract of land located within a portion of Bristol Township, Bucks County, Pennsylvania, bound and described as follows:

Beginning at a point located where the centerlines of Zimmerman Lane; Durham and New Falls Roads intersect;

- thence traveling in a southwesterly direction along the centerline of New Falls Road a distance of approximately five hundred and fifty (550') feet to a point located along the service territorial line for Aqua's Bristol Borough Water Authority Acquisition (Docket: A212370F0028);
- thence traveling in a southeasterly direction along Aqua's territorial line for Aqua's Bristol Borough Acquisition a distance of approximately four hundred (400') feet to a point;
- thence traveling in a southwesterly direction along Aqua's territorial line for Aqua's Bristol Borough Acquisition a distance of approximately four hundred (400') feet to a point located on the easterly right of way line for I-95;
- thence traveling in a southeasterly direction along Aqua's territorial line for Aqua's Bristol Borough Acquisition (crossing the PA Turnpike) a distance of approximately two thousand and two hundred (2,200') feet to a point;
- thence traveling in a southwesterly direction along Aqua's territorial line for Aqua's Bristol Borough Acquisition approximately three hundred and fifty (350') feet to a point along the easterly right-of-way line of I-95;
- thence traveling in a southerly direction along Aqua's territorial line for Aqua's Bristol Borough Acquisition and also along the easterly right-of-way line for I-95 a distance of approximately one thousand two hundred (1,200') feet to a point located about the intersection of the easterly right-of-way line of I-95 and the centerline of Ford Road;
- thence traveling in a northeasterly direction along Aqua's territorial line for Aqua's Bristol Borough Acquisition and also along the centerline of Ford Road a distance of approximately six hundred and fifty (650') feet to a point wherein the centerlines of Ford and Wharton Roads intersect;
- thence traveling in a southeasterly direction along Aqua's territorial line for Aqua's Bristol Borough Acquisition and also along the centerline of Wharton Road a distance of approximately one thousand six hundred (1,600') feet to a point,
- thence traveling in a northeasterly direction along Aqua's territorial line for Aqua's Bristol Borough Acquisition a distance of approximately nine hundred and fifty (950') feet to a pointing located in the centerline of New Rodgers Road (SR 413);

- thence traveling in a southerly direction along Aqua's territorial line for Aqua's Bristol Borough Acquisition and also along the centerline of New Rodgers Road (SR 413) a distance of approximately one thousand one hundred (1,100') feet to a point;
- thence traveling in a southwesterly direction along Aqua's territorial line for Aqua's Bristol Borough Water Acquisition a distance of approximately seven thousand and seven hundred (7,700') feet to a point located along the service territorial line to Aqua's Bensalem Township Acquisition (see Docket: A212370F0054);
- thence traveling in a northerly direction along Aqua's service territorial line for Aqua's Bensalem Township acquisition a distance of approximately ten-thousand nine hundred (10,900') feet to a point located on Zimmerman Lane projected westerly where it would intersect with Aqua's service territorial line for its Bensalem Township Acquisition;

Thence continuing in an easterly direction along the centerline of Zimmerman Lane (crossing I-95) a distance of approximately two thousand eight hundred and fifty (2,850') feet to the aforementioned point and place of beginning.

The aforementioned Requested Territory contains approximately 936 acres.
