My insurance agent, Daniel Conville, located at 464 S Washington Street Eau Claire Pa, had rewritten my Commercial auto policy with a different Carrier effective for April 12, 2013. He in turn cancelled the prior policy with Progressive. He and I were totally unaware that the E-filing and H- filing had to be on the new policy. When I received the initial notice that these coverages needed to be present, I promptly notified Dan. He then in turn added the E-filing and attempted to add The H Filing and sent over proof of insurance. Unfortunately, the new insurance company did not offer the H-filing and this was never added.

This is now corrected. I have secured Insurance with Progressive again and this policy provides both filings required for my continued compliance. I trust you will understand and see that I would have never knowingly violated any of the obligations that I have with the PUC.
