**ORDER**

**BY THE COMMISSION:**

On April 30, 2009, Premier Power Solutions, LLC (Premier) filed a request to amend its electric generation supplier license to include the service territories of all electric distribution companies, within the Commonwealth of Pennsylvania.

On May 8, 2006, Premier filed an Application to offer, render, furnish or supply electricity or electric generation services as a consultant to commercial, industrial and governmental customers in the service territories of Duquesne Light Company and Pennsylvania Power Company, within the Commonwealth of Pennsylvania. On July 26, 2006, the Commission approved a license at Docket No. A-110170, authorizing Premier to begin to offer, render, furnish or supply electricity or electric generations services as a consultant to commercial, industrial and governmental customers, within the service territories of Duquesne Light Company and Pennsylvania Power Company. On April 30,

2009, Premier filed a request to amend its electric generation supplier license to include the service territories of the remaining electric distribution companies; West Penn Power Company d/b/a Allegheny Power, Citizens' Electric of Lewisburg, Metropolitan Edison Company, PECO Energy Company, Pennsylvania Electric Company, Pike County Light & Power Company, PPL Electric Utilities, Inc., UGI Utilities, Inc. and Wellsboro Electric Company, within the Commonwealth of Pennsylvania.


Premier published notice of its original license application in the Pennsylvania newspapers as required by the Commission to provide service in all service territories, within the Commonwealth of Pennsylvania.

Upon full consideration of all matters of record, we find that approval of this request is necessary and proper for the service, accommodation and convenience of the public; **THEREFORE,**

**IT IS ORDERED:**

1. That the Request of Premier Power Solutions, LLC is hereby approved, consistent with this Order.
2. That a license be issued authorizing Premier Power Solutions, LLC to begin to offer, render, furnish or supply electric generation supplier services to the public in the service territories throughout the Commonwealth of Pennsylvania.
3. That a copy of this Order be served on the Department of Revenue, Bureau of Corporation Taxes.
4. That this proceeding at Docket No. A-110170 be closed.
