




MISSION STATEMENT

Letter to Stakeholders

As I write this letter, energy users across Pennsylvania are engaged in energy conservation, energy efficiency, and renewable energy projects that move the Commonwealth towards a sustainable energy future. Admittedly, this is a future that is difficult to envision, but necessary for the success of our children and grandchildren. It is this necessity that drives our mission, our entrepreneurial spirit, and our success.



In fiscal year 2013, Sustainable Energy Fund committed more than \$1.9 million to sustainable energy projects to businesses, provided more than 1,600 hours of educational content, and granted more than 160 Energypath scholarships. The \$1.9 million in commitments for 946 projects to businesses resulted in \$2.2 million in disbursements for 946 projects. The projects ranged from a \$227 instant rebate to a \$1.25 million line of credit.

Through monthly Power Lunches and experiential exhibit booths, Sustainable Energy Fund provided more than 1,600 educational hours. Additionally, Sustainable Energy Fund co-hosted a symposium on translating local success to global success with the United Nations Industrial Development Organization.

This year, Sustainable Energy Fund participated in the Pennsylvania Public Utility Commission's working group on On-Bill Financing. Sustainable Energy Fund collaborated with stakeholders to develop a model specifically for Pennsylvania.

We are proud of the results and international recognition we achieved during the past year, but know that continued success will take great effort. We also recognize that our success is a reflection of the commitment and leadership of our Board of Directors.

OVERCOMING EDUCATIONAL BARRIERS

Sustainable Energy Fund assists in overcoming educational barriers by providing opportunities for energy users to increase their knowledge of energy conservation, energy efficiency, and renewable energy. This increase in knowledge is accomplished through experiential displays at public expositions, speakers, and hands-on and classroom training. Sustainable Energy Fund's educational training is branded, Energypath.



Last year, Sustainable Energy
Fund participated in numerous
public expositions including
the Pennsylvania Farm Show,
Globalcon, PA Science Teachers
Convention, PBEA Conference,
PV America and others. At each of
these events, Sustainable Energy
Fund brought demonstration units
that allowed all participants to see
and touch the latest renewable
energy technologies.


The United Nations Industrial
Development Organization
and Sustainable Energy Fund
hosted the Sustainable Energy
Symposium. The symposium
focused on the challenges of
implementing sustainable energy at
the local and global level.

Sustainable Energy Fund provides speakers for community organizations and events. During the last year, Sustainable Energy Fund speakers participated in a variety of events including Globalcon, PV America and the KEEA Energy Efficiency Conference among others.

Hands-on and classroom training are provided through the **Energypath Power Lunch and** annual Energypath event. Power Lunch is a one-hour lunch-andlearn held monthly on a sustainable energy topic. They are held in Harrisburg and Allentown. In 2005, Sustainable Energy Fund launched the award-winning Solar Scholars[™] program. Since then, this program has grown into the region's largest sustainable energy conference attracting almost 500 participants annually. Today, the event, known as Energypath, features a two-day conference, three-day preconference hands-on energy camps, sustainable energy exposition and science fair for both middle school and high school students.

SOURCES OF SUPPORT

Sustainable Energy Fund's operating funds come from two main funding sources: revenue from program-related investments and investment income. Total Sustainable Energy Fund operating revenues and gains for fiscal year 2013 were \$1,299,87. Total expenses were \$1,037,490.



OVERCOMING FINANCIAL BARRIERS

In fiscal year 2013, Sustainable Energy Fund assisted energy users in overcoming financial barriers through financial education and lending programs. Energy Service Providers learned how to evaluate financial instruments and sell financing for energy projects. Project financing was facilitated through both direct and indirect lending programs. Indirect lending programs included the Instant Rebate Program marketed by AllFacilities Energy Group and a line of credit for AFC First Financial to use in the Keystone Help loan program.

By working with AllFacilities Energy Group and AFC First Financial, Sustainable Energy Fund was able to reach more than 900 ratepayers who included homeowners, school districts, manufacturers and others. In total, Sustainable Energy Fund committed \$1.9 million and disbursed almost \$2.3 million impacting 946 projects.


