Dear Secretary Chiavetta:

Enclosed please find an original, a copy and a disk of West Penn Power Company's ("WPP") <u>Amended</u> Final Annual Report to the Pennsylvania Public Utility Commission and Act 129 Statewide Evaluator for the period June 2012 through May 2013, Program Year 4.

Based on feedback from the Commission's Bureau of Technical Utility Services, WPP has produced an amended Phase I Annual Report that provides further detail surrounding reduction impacts during the Company's Top 100 hour period. Information contained in this report is consistent with data provided directly to the Statewide Evaluator ("SWE") and in response to SWE data requests.

Specifically, WPP has amended Tables and Figures to distinctly show 3 scenarios for reporting Top 100 Hour Demand Reduction Impacts, as specified below:

- 1. On-TRM results consistent with published 2012 TRM protocols, referred to as "TRM Top 100 Hours MW Achieved" or "TRM" throughout the report.
- 2. Results that correct the TRM to reflect an 8.8% Residential CFL coincidence factor consistent with previous joint utility comments to SWE and TUS Staff¹. These results are referred to as "TRM Corrected Top 100 Hours MW Achieved" or "TRM Corrected" throughout the report.
- 3. Results informed by evaluation activities that include specific deviations from the 2012 TRM protocols to more accurately assess the impacts of Residential Lighting during the

Company's Top 100 Hours. WPP believes these more precise evaluation results best demonstrate compliance with ACT 129's unique Demand Reduction target. These results are referred to as "Evaluated Top 100 hours MW Achieved" or "Evaluated" throughout the report.

In addition to providing these demand reduction details, WPP's filings also include edits to correct certain financial, TRC, and other information provided in the original filings made on November 15, 2013.


