Dear Mr. Cravener:

On May 9, 2002, the Commission issued a license at Docket No. A-125108, authorizing Snyder Brothers, Inc. the right to begin to offer, render, furnish or supply natural gas supply services to commercial, industrial and governmental customers, within the service territory of Dominion Peoples, within the Commonwealth of Pennsylvania.

On October 30, 2002 and February 10, 2006, the Commission approved, by Secretarial Letter, the modification of Snyder Brothers, Inc.'s license to include the additional service territories of Columbia Gas of Pennsylvania, Inc. and the Equitable Gas Company, within the Commonwealth of Pennsylvania.

On June 27, 2007, Snyder Brothers, Inc. filed a request that the Commission amend its license to authorize it to provide natural gas supply services to the public in the additional service territory of National Fuel Gas Distribution Corporation, within the Commonwealth of Pennsylvania.

Snyder Brothers, Inc. has provided proper documentation as required by this Commission.


