This letter has reference to your Order of January 17, 1989 granting the Motion of Central Transport, Inc. with respect to discovery sought by Central from protestant Matlack, Inc. and our several conversations on Friday, January 20 with respect thereto.

As I advised you, we were not served with a copy of the Central Motion which resulted in your Order and thus did not reply thereto. We have confirmed that the Motion was, mistakenly not sent to us by Central. Counsel for Central has mailed a copy of its Motion to us on Friday, January 20 and we will respond by Friday, January 27.

I understand that you will revoke or otherwise withdraw your January 17, 1989 Order and will consider Matlack's Reply before determining the result and issuing a new Order.

In the event your Order requires additional information and/or documents from Matlack, there is a possibility that the material will not be able to be prepared and supplied to Central in time for the hearings now scheduled for February 7, 8 and 9. If this occurs, we will endeavor to make ourselves available for a further hearing later in February or in early March.


