We are counsel to EQT Energy, LLC, d/b/a Equitable Energy, a licensed natural gas supplier in the Commonwealth of Pennsylvania at PaPUC Docket No. A-125013. EQT Energy, LLC was known as Equitable Energy, LLC in 1999 when it received its natural gas supplier's license but changed its business entity name to EQT Energy, LLC in 2009. By this letter, we are formally advising the Public Utility Commission of the name change. Although it changed its entity name in 2009, EQT Energy has always conducted and continues to conduct its retail natural gas supply business as Equitable Energy. 
