

PECO is aware that EQT Energy, LLC d/b/a Equitable Energy has applied for a license to provide brokering and consulting services to commercial and industrial customers on the distribution system of PECO.


In making such an application, EQT Energy, LLC d/b/a Equitable Energy must furnish a bond or other acceptable financial security in an amount that PECO determines to be appropriate. EQT Energy, LLC d/b/a Equitable Energy has indicated that it intends to provide only brokering and consulting services to commercial and industrial customers, and will not take title to any delivered natural gas. Therefore, we have determined at this time EQT Energy, LLC d/b/a Equitable Energy does not need a bond or other financial security requirement to provide consulting services to PECO customers.

However, if the services provided by EQT Energy, LLC d/b/a Equitable Energy, or the creditworthiness requirement for PECO's exposure to EQT Energy, LLC d/b/a Equitable Energy changes in the future, PECO reserves the right to require EQT Energy, LLC d/b/a Equitable Energy to provide a bond or other financial security instrument.

And, based on the fact that EQT Energy, LLC d/b/a Equitable Energy ("EQT Energy") is not currently serving Choice customers in the PECO service territory and your assertion that EQT Energy, LLC d/b/a Equitable Energy does not intend to serve customers in the PECO service territory in the future, PECO has concluded that EQT Energy, LLC d/b/a Equitable Energy will not need to post security with PECO. If EQT Energy, LLC d/b/a Equitable Energy wishes to directly serve Choice customers in the PECO service territory in the future as a natural gas supplier, it will have to post security as specified in the PECO tariff prior to the commencement of the service.

This letter is with regard to the operation of EQT Energy, LLC, d/b/a Equitable Energy, as a licensed natural gas supplier on the distribution systems of Peoples Natural Gas Company LLC, Peoples Natural Gas LLC – Equitable Division, and Peoples TWP LLC (“the Companies”). Since Equitable Energy is winding down its supplier operations and conveying its book of business to UGI Energy Services, LLC, we have determined at this time that Equitable Energy does not need a bond or other financial security in order to provide its current services to the Companies’ ratepayers.

If the Companies’ credit exposure to Equitable Energy changes in the future due to Equitable Energy’s operation as a natural gas supplier on the Companies’ systems, or Equitable Energy’s creditworthiness changes, the Companies may deem it appropriate to require a bond or other credit support.

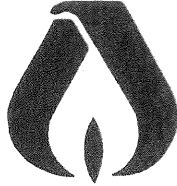
