





In July 2013 we notified the PUC that Elite Carriages Inc. would no longer be in business and accepted a voluntary suspension. At that time we were *not* informed that it was necessary to file a form that stated abandonment. We were told that the PUC tax was still due. We paid that tax. Now we have not been in service for well over a year, our assets were liquidated last year and our license remained suspended. Now I received another bill for PUC tax for 2014 and when I called and questioned it, I was *now* informed that a certificate of abandonment must be filed.

I hereby respectfully request that my case be reviewed so that with your cooperation this tax/ fee will be waived and my business can be put to rest once and for all. I have no assets and am filing the abandonment form as I was now informed I needed to do. 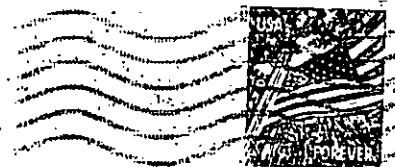
