
Our clients hereby request that the Final Rulemaking Order dated November 13, 2014, which was subsequently modified by the Tentative Reconsideration Order adopted December 18, 2014, be further changed to eliminate the 350,000 mile restriction as it relates to alternative fuel vehicles. The Commission correctly recognized in its Final Rulemaking Order that alternative fuel vehicles have substantially longer use cycles than regular taxicabs but nevertheless restricted those vehicles to a 350,000 mileage limitation. It is respectfully submitted that this mileage limitation should be eliminated for qualifying alternative fuel vehicles. To the extent required, please consider this letter as a Petition for Reconsideration of the Final Rulemaking Order.
