



2. PLACE NEW FIBER OPTIC CABLE AND STRAND (ON EAST POLE) 2'-2" ABOVE CATV, THEN LOWER TO 5'-10" BELOW TELE CO CABLE (TO PROVIDE CLEARANCE BELOW RAILROAD BRIDGE).


