4. THIS AERIAL RAILROAD CROSSING IS FOR FIBER OPTIC CABLE TO BE BUILT ON EXISTING POLES IN ROAD RIGHT OF WAY. PLAN, PROFILE DRAWINGS, AND PICTURES OF THE EXISITING CROSSING ARE ATTACHED.

8. The ALTERATION is necessary or proper for the following reasons TO EXPAND SERVICE AREA TO NEW BUSINESS AND RESIDENTIAL CUSTOMERS WHO WISH TO HAVE HIGH SPEED INTERNET SERVICE AT A REASONABLE PRICE.



3. NEW FIBER OPTIC CABLE AND STRAND CLEARANCE ABOVE RAILROAD TRACKS WILL BE 25'-11.

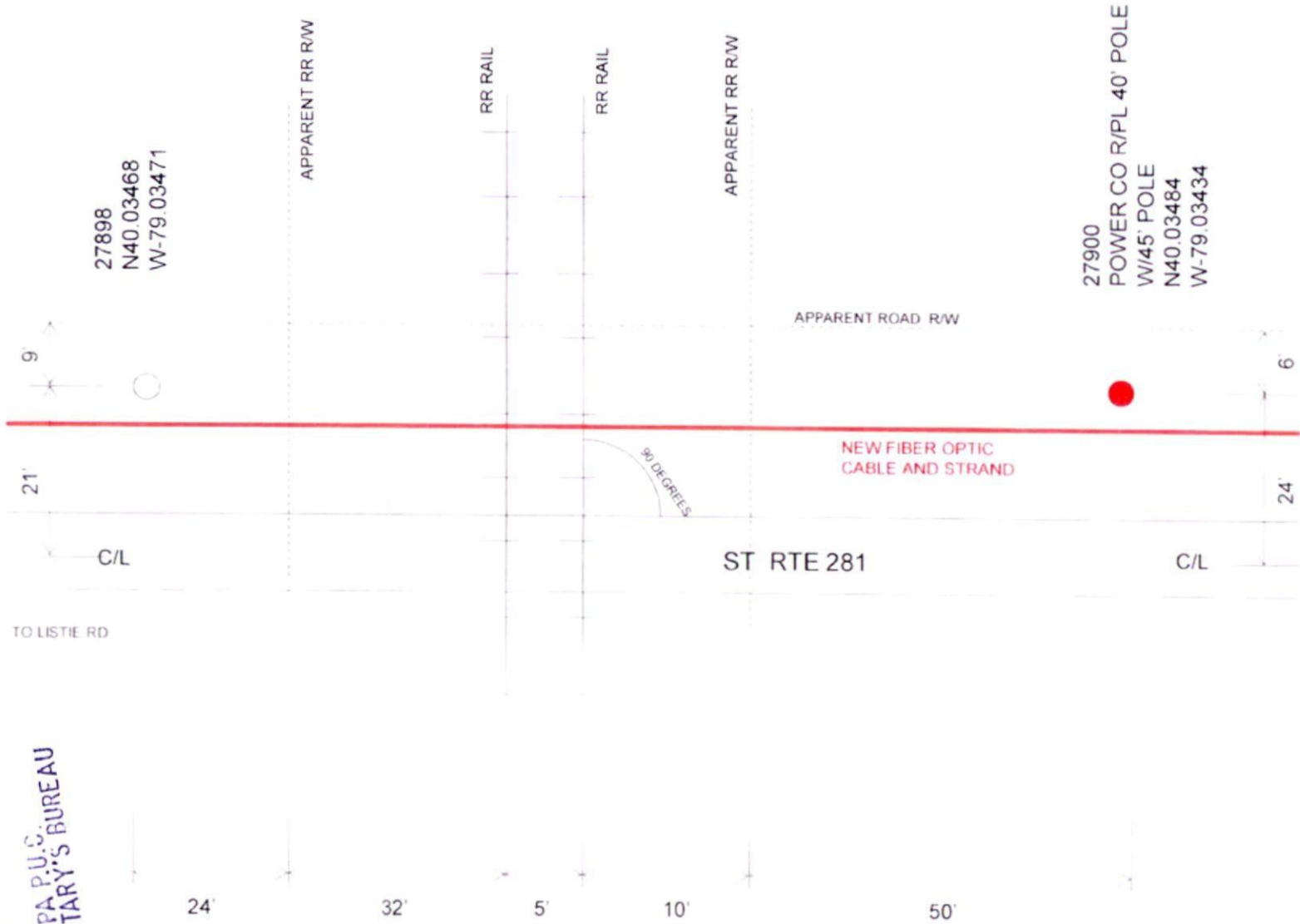

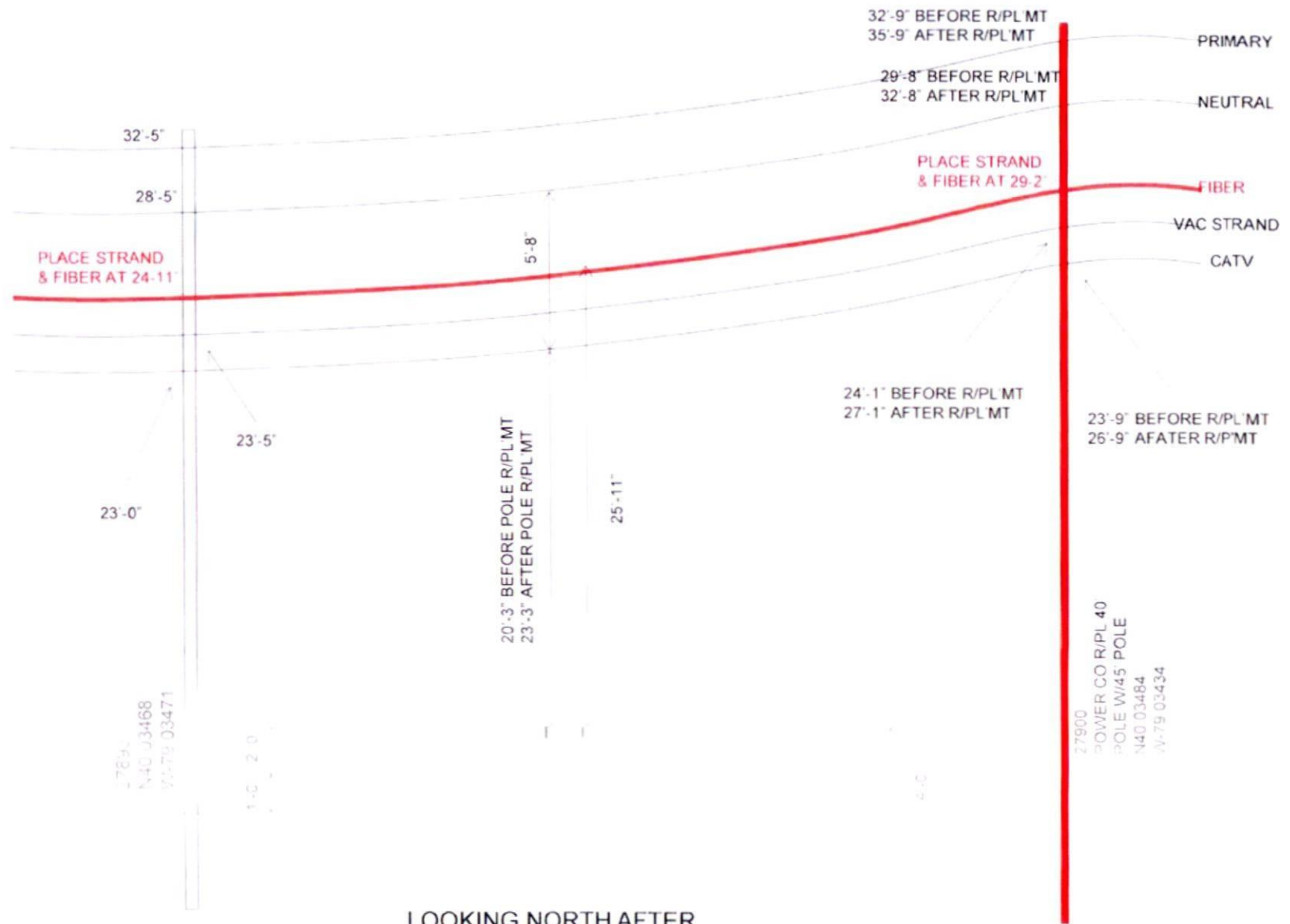

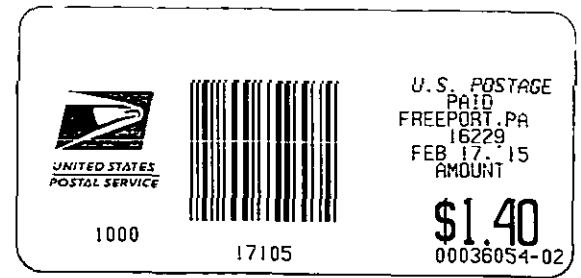
