3. Comcast wishes to construct a communication facility in Straban Township, Adams County, PA. To complete the system, the communication facility must cross CSX Transportation rails within the public right-of-way of Granite Station Road. The communication facility will be placed above ground from utility pole Met Ed 16587-C19074 to utility pole Met Ed 16567-C19084.

4. The proposed construction will be a communication facility placed between utility poles on either side of the railroad crossing. The fiber optic communication facility will be aerial. The railroad intersects Granite Station Road at grade. See attached Exhibit "A". The completion date for this project is June 30, 2015.

5. The public utilities, municipalities, corporations and property owners concerned in, or affected by, the crossing alteration are identified in Exhibit "B" attached hereto.

6. Because the aerial communication line will have no impact on rail traffic or the motoring public, no vehicle use data has been developed in connection with this application. Comcast will follow its normal procedure for construction of a communication facility within a public right-of-way along a public roadway. Comcast uses construction procedures including the use of warning devices and flagmen to maintain, as nearly as possible, the normal flow of vehicular traffic.

7. The expected cost for the construction procedure is \$1000. Comcast will pay all costs of construction of the aerial communication line, as well as, be responsible for installing, maintaining and inspecting the facilities.

8. The alteration is necessary or proper for the following reasons: to provide adequate, efficient, and reasonable communication facilities to the public in Adams County and surrounding areas.
