

3. SALSGIVER COMMUNICATIONS PROVIDES HIGH SPEED TELEPHONE INTERNET SERVICE TO BUSINESS AND RESIDENTIAL CUSTOMERS. SALSGIVER TELECOM IS A TELECOMMUNICATIONS COMPANY.

4. THIS AERIAL RAILROAD CROSSING IS FOR FIBER OPTIC CABLE TO BE BUILT ON EXISTING POLES IN ROAD RIGHT OF WAY. PLAN, PROFILE DRAWINGS, AND PICTURES OF THE EXISITING CROSSING ARE ATTACHED.





CROSSING 12 NOT TO SCALE SHEET 1 OF 8








CROSSING 12 NOT TO SCALE SHEET 4 OF 8




LOOKING NORTHEAST


