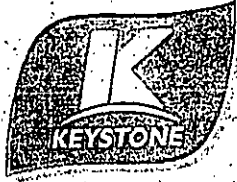



To Whom It May Concern:

Enclosed with this Letter, please find the following documents regarding information that **must be filed** with the Pennsylvania Public Utility Commission (Commission or PUC):

I. Public Utility Security Planning and Readiness Self-Certification Form (Self-Certification Form) and Self-Addressed Envelope

- Pursuant to 52 Pa. Code Chapter 101, effective June 11, 2005, the Commission requires that utilities under the reporting requirements of 52 Pa. Code §§ 57.47 (electric service), 59.48 (gas service), 61.28 (steam heating service), 63.36 (telephone service), 65.19 (water service), 29.43 (Motor Carriers of Passengers), 31.10 (Motor Carrier Property Transportation) and 33.103 (Railroad Transportation) shall file the enclosed Self-Certification Form with the Commission by **April 30th** of each year.
- Please note that the reporting year ("Year Ended" blank) is **2013** as the Self-Certification Form is used to certify compliance during the **previous** calendar year.
- A completed Self-Certification Form must be sent back to the Commission in **one** of the following ways: (the Self-Certification Form **cannot be eFiled**)
 - Complete the paper version of the Self-Certification Form enclosed with this Letter and **mail the form to the Commission in the enclosed self-addressed envelope after affixing proper postage.**

OR

- Complete the **fillable Self-Certification Form located on the Commission's website at http://www.puc.pa.gov/filing_resources/online_forms.aspx** (click on the appropriate utility group), save the completed form (or print the completed form, scan and upload the form) and **email the form to RA-PCSELF CERT@pa.gov.**
