By this letter, Shipley Energy Company ("Shipley") requests that its Pennsylvania electricity supplier license at Docket No. A-110069 be canceled. Shipley is not currently serving any customers under this license. Further, a Shipley affiliate, Convenient Ventures, LLC d/b/a EnergyObjective, was recently granted an electricity supplier license, at Docket No. A-2014-2446928, by Commission Order entered December 4, 2014. Electricity supply services will be provided in the future by EnergyObjective, rather than Shipley Energy Company. In addition, Shipley requests that the bond currently being held by the Commission be released.
