- 1. **Proposed service limitations:** In your application you had TWO replies to question #9. One stated that you wished to limit your service to people requiring wheelchair or litter transport to or from medical appointments; in your second response you indicated limiting service to people whose personal convictions prevent them from owning or operating motor vehicles (typically "Amish") both proposals appear to wish to operate in different areas. Please clarify what you are asking for.
- 2. Service area proposed: as submitted, your proposed service area is insufficiently defined. What is essential is that the proposed operating area be FULLY defined. We are chiefly concerned with the areas from which you wish to ORIGINATE service. You may propose statewide, but be advised that you will be required to obtain at least 5 statements of support from persons residing in each county you wish to service. Ensure that any proposed operating area is fully bound and easily discernible. This is most typically done by means of municipal boundaries (city, township, county, etc.), but may also be done by use of roads, waterways, rail lines, etc. If you wish to service an entire county please just indicate the County, and not all the boroughs, townships, and smaller municipal subdivisions contained within.
