**PETITION TO INTERVENE OF  
THE COLUMBIA INDUSTRIAL INTERVENORS**

---

Pursuant to Sections 5.71 through 5.74 of the Pennsylvania Public Utility Commission's ("PUC" or "Commission") Regulations, 52 Pa. Code §§ 5.71 - 5.74, the Columbia Industrial Intervenors ("CII") hereby file this Petition to Intervene in the above-captioned proceeding. In support thereof, CII asserts as follows:

1. For purposes of this proceeding, CII includes the companies listed in Appendix A hereto. CII will update Appendix A during the course of this proceeding as needed to reflect changes in its membership.

2. The names and address of CII's attorneys are:

3. On February 27, 2015, Columbia Gas of Pennsylvania, Inc. ("Columbia" or "Company") made its preliminary Purchase Gas Cost ("PGC") filing with the Commission pursuant to Section 1307(f) of the Public Utility Code. *See* 66 Pa. C.S. § 1307(f). Columbia's filing indicates that the Company will submit its annual PGC filing on April 1, 2015.

4. CII is an ad hoc group of energy-intensive customers receiving service from Columbia under both sales and transportation rate schedules, including Rate LDS (Large Distribution Service) and Rate LGSS (Large General Sales Service). CII members use substantial volumes of natural gas in their manufacturing and operational processes, and natural gas costs comprise a significant element of their respective costs of operation. The PUC's disposition of Columbia's 1307(f) filing may impact the rates CII members pay for natural gas service.


5. Columbia proposes a decrease of \$0.14050/therm to its PGC rate, from \$0.53891/therm to \$0.39841/therm, applicable to customers served under Rate RSS (Residential Sales Service), Rate RDGSS (Residential Distributed General Sales Service), Rate SGSS (Small General Sales Service), Rate LGSS, and Rate MLSS (Main Line Sales Service). Accordingly, the Commission's resolution of these issues may impact the sales rates applicable to CII members.

6. Therefore, consistent with 52 Pa. Code § 5.72(a), CII has a significant interest in this proceeding that is not represented by any other party of record. Consequently, CII should be granted intervenor status in this proceeding.

**WHEREFORE**, for the reasons stated above, the Columbia Industrial Intervenors respectfully request that the Pennsylvania Public Utility Commission grant this Petition to Intervene and provide the Columbia Industrial Intervenors with full-party status in this proceeding.
