Dear Commission Secretary:

It was announced on July 30, 2014 that Exelon Corporation ("Exelon") and Integrys Energy Group, Inc. entered into a definitive agreement for Exelon to purchase Integrys Energy Services, Inc., including its subsidiaries Compass Energy Services, Inc., Compass Energy Gas Services, LLC, and Integrys Energy Services – Natural Gas, LLC. That transaction closed effective November 1, 2014.

Licensee submits this notice regarding its Natural Gas Supplier authority. Licensee changed its name effective April 1, 2015 to Constellation Energy Services, Inc. Attached is the Certificate of Amended Registration changing the name of Licensee to "Constellation Energy Services, Inc.".

Licensee remains the same standalone corporate entity and its DUNS Number and Federal Taxpayer Identification Number remain the same.
