**JOINT PROTEST OF HOMESTEAD TAXI, LLC AND
HOMESTEAD TRANSPORTATION, LLC**

TO THE HONORABLE PENNSYLVANIA PUBLIC UTILITY COMMISSION:

AND NOW, comes Homestead Taxi, LLC and Homestead Transportation, LLC (hereinafter, collectively, "Protestants"), by their attorney, and, in protest to the Application of Granny's Helping Hands PA, Inc. t/a Let's Go Transportation, LLC ("Applicant") for authority to transport persons, upon call or demand, as set forth therein, respectfully represents the following:

4. Applicant has applied for authority to provide call or demand service in the Counties of Delaware, Montgomery, Chester and Bucks. Protestants hold call or demand authority, including call or demand authority in Montgomery and Bucks Counties, in conflict with what the Applicant seeks through its application. The call or demand authority of Protestant Homestead Taxi, LLC at A-00117413, Folder 1, and Folder 1, Am-A, upon which its protest is predicated is attached hereto as Attachment A and made a part hereof. The call or demand authority of Protestant Homestead Transportation, LLC at A-00123118 and A-2010-2165832, upon which its protest is predicated is attached hereto as Attachment B and made a part hereof.

5. Absent on the record presentations, Protestants do not believe there is a need for the proposed service as described in the Application. In addition, there is no evidence that Applicant can meet the criteria in 52 Pa. Code § 41.14 and, thus, approval of the Application would be contrary to the public interest.

6. Protestants submit further that the entry of a new carrier would endanger or impair the operations of existing carriers to an extent that, on balance, the granting of authority would be contrary to the public interest.

7. In sum, approval of this Application, as currently constituted, is not necessary or proper for the service, accommodation, convenience or safety of the public.

8. Protestants' interests would be protected if Applicant would completely remove Protestants' authorized service territory from Applicant's proposed service territory.


9. Pursuant to Section 333(c) of the Public Utility Code, demand is made upon Applicant to furnish to Protestants' counsel a list of the names and addresses of the witnesses, names and addresses of the entity that they represent, if any, and the

subject matter of their expected testimony. This is a continuing request and is applicable to all witnesses to be called.

WHEREFORE Homestead Taxi, LLC and Homestead Transportation, LLC request that the Pennsylvania Public Utility Commission deny and dismiss the Application of Granny's Helping Hands PA, Inc. t/a Let's Go Transportation, LLC at Docket No. A-2015-2469125.

OPERATING AUTHORITY

Folder 1

To transport, as a common carrier:

- (1) persons upon call or demand in the borough of Sellersville, Bucks County
- (2) persons upon call or demand in the borough of Perkasio, Bucks County
- (3) persons upon call or demand within the portion of West Rockhill Township beginning at a point at the intersection of Lawn Avenue and Highway Route 563 (Ridge Road), thence west along Highway Route 563 to the intersection of Highway Route 563 and L.R. 09106 (Ridge Valley Road), thence northwest along L.R. 09106 (Ridge Valley Road) to the Milford Township Line, thence west along Milford Township line to the boundary line between Montgomery County and Bucks County, thence south along said boundary between Montgomery County and Bucks County, to the boundary of the borough of Telford, thence east and south along the boundary lines of the borough of Telford to the intersection of said boundary line and T 429 (Township Line Road), excluding all points within the borough of Telford, thence east along T 429 to the Sellersville borough line thence north and east along the Sellersville borough line to Old Bethlehem Pike, thence north along Old Bethlehem Pike to Highway Route 563 (Ridge Road), thence west along Highway Route 563 to the point of beginning;
- (4) persons upon call or demand in that portion of East Rockhill Township beginning at the northern boundary of Perkasio borough and East Rockhill Township at Ridge Road east of the intersection of Blooming Glen Road, thence east along Ridge Road to the eastern boundary of East Rockhill Township, thence south along said boundary to a point at the intersection of said boundary and Highway Route 313, thence west along the southern boundary of East Rockhill Township to the eastern boundary of Perkasio borough (at Callowhill Road), thence north along the eastern boundary of Perkasio borough to the point of beginning;
- (5) persons upon call or demand in the borough of Quakertown, Bucks County
- (6) persons upon call or demand in that portion of the county of Bucks bounded as follows: beginning at the intersection of traffic route 563 (TR 563), and Legislative Route 09106 (L.R. 09106) in the township of West Rockhill thence in a westerly direction along L.R. 09106 to its intersection with L.R. 09111, thence along L.R. 09111, in a northerly direction and thence in an easterly direction to the northeast extension of the Pennsylvania Turnpike, thence along said Turnpike in a northerly direction to L.R. 09109, thence in a westerly direction along L.R. 09109 to its intersection with TR 663, thence along TR 663, and an unnamed

road in a northeasterly direction to the point of meeting of the said northeastern extension of the Pennsylvania Turnpike and L.R. 09097, thence along L.R. 09097 in a northeasterly direction and an easterly direction to its intersection with the Old Bethlehem Pike (Route 153 Spur), thence along said Old Bethlehem Pike to L.R. 09094, thence along L.R. 09094 in an easterly direction to U.S. Route 309, thence in a northerly direction along U.S. Route 309 to L.R. 09089, thence along L.R. 09089 in an easterly direction to Richlandtown borough, thence in a northerly direction around the western boundary of Richlandtown borough to L.R. 09080, thence in a northerly direction along L.R. 09080 to L.R. 09145, thence in an easterly direction along L.R. 09145 to its intersection with Pennsylvania State Route 212, thence east on Pennsylvania State Route 212 to its intersection with L.R. 09127, thence in an easterly direction along L.R. 09127 to L.R. 09068, thence in a southerly direction along L.R. 09068 to L.R. 09019, thence along L.R. 09019 in an easterly direction to L.R. 09130 and in a southerly direction along L.R. 09130 to Nockamixon State Park, thence via an imaginary line through Nockamixon State Park to the intersection of Ridge Road and L.R. 09093, thence westerly on Ridge Road to its intersection to L.R. 09090, thence north via L.R. 09090 to its intersection with L.R. 09102 thence via L.R. 09102, to its intersection with Park Avenue, thence via Park Avenue to its intersection with Pennsylvania Traffic Route 563, thence south via Pennsylvania Traffic Route 563 to the point of beginning; and
