ANSWER OF THE OFFICE OF SMALL BUSINESS ADVOCATE

Pursuant to 52 Pa. Code §5.61(e), the Office of Small Business Advocate ("OSBA") hereby answers the Petition filed by PECO Energy Company ("PECO" or "Company") with the Pennsylvania Public Utility Commission ("Commission") on March 27, 2015, and avers the following in support thereof:

- 1. The OSBA is an agency of the Commonwealth of Pennsylvania authorized by the Small Business Advocate Act (Act 181 of 1988, 73 P.S. §§ 399.41 399.50) to represent the interest of small business consumers as a party in proceedings before the Commission.

 Concurrent with the filing of this Answer, the OSBA is filing a Notice of Intervention and Public Statement in connection with the above-captioned proceeding to protect the interest of the Company's small business customers.
- 2. In the Petition, the Company seeks approval of its Electric Long Term Infrastructure Improvement Plan ("LTIIP") and to establish a distribution system improvement charge ("DSIC") for its electric operations. Accordingly, PECO requests that the Commission authorize the Company to file the tariff supplement attached to its Petition as PECO Exhibit No. 2 ("DSIC Tariff") on at least one days' notice to become effective on January 1, 2016.

3. After preliminary review of the materials filed by the Company in support of the

Petition, the OSBA believes, and therefore avers, that the Company's proposals may be unjust,

unreasonable, and unlawfully discriminatory in violation of, inter alia, Sections 1301 and 1304

of the Public Utility Code, 66 Pa.C.S. §§1301 and 1304, and contrary to appropriate public

policy and sound ratemaking considerations, and may not be supported by the materials filed by

the Company.

4. In view of the foregoing, the Office of Small Business Advocate respectfully

requests that the Commission:

a. Suspend and investigate the operation of PECO's proposed tariff changes;

b. At the conclusion of such investigation, reject the proposed tariff changes to the extent required to insure that PECO's rates are lawful, just, reasonable and

not unduly discriminatory; and

c. Grant such other relief as may be necessary or appropriate.

WHEREFORE, the Office of Small Business Advocate respectfully requests that the

Commission refer the Petition to the Office of Administrative Law Judge for investigation and

hearings and the preparation of a Recommended Decision.

On March 27, 2015, PECO Energy Company ("PECO" or "Company"), filed a Petition for approval of its Electric Long Term Infrastructure Improvement Plan ("LTIIP") and to establish a distribution system improvement charge ("DSIC") for its electric operations, initiating the above-captioned proceeding.
