I write to formally request a public input hearing on the PECO Energy Company (Docket No. R-2015-2468981) rate increase request. Over the last decade, PECO has received multiple rate increases, and on its face, these requests for additional revenues have not resulted in improved services.

In light of the fact that PECO has spread its service area to other companies, I believe it has lessened PECO's responsibility to its customers. I am not certain that there is a need for a rate increase when the company is servicing less customers.

I would like the PUC to convene a hearing in Philadelphia, possibly in the 181<sup>st</sup> Legislative District at Northern Liberties Neighborhood Association, West Poplar Community Development Corporation, Temple University or Fairhill Community, so that my constituents have the opportunity to voice their thoughts and concerns.

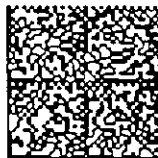
